Trustees Spring 2024 report

- Established a fund in the church budget for a choir loft chair lift. The expected expense is estimated to be \$10,000. Project will be completed when we have the funds to do the job. Donations from the church members are encouraged as each family feels moved to help support the choir.
- Added 3 downspouts around the church to help with drainage.
- Bathroom toilet repairs are ongoing and converting flapper system to a newer style. Thanks to the LWML donated \$500 to assist in the effort.
- We are having a contractor perform shrub trimming around the church three times per year to keep the property looking good and allow the church to utilize volunteers in other efforts around the church.
- Several attempts to patch the roof from the mailboxes to the lobby but we keep having more issues. The roof needs to be replaced. The plan is to replace the roof this June utilizing some CDs that will mature with an expected cost of \$26,000. This was not in the church budget but necessary.
- Prayer garden eave repair was made outside the library. This was relate to the age of the roof.
- Added more shelf space in the attic. Shelf is 16 feet long by 4feet deep. This space is available for our church groups but we ask that everything be stored in plastic, not cardboard and please label containers for easy identification.
- AED is in service and located in the lobby. Adult pads are installed but child pads are also available
 with the kit. Teachers will be trained in how to swap the pads out when they complete their CPR
 training. Please make sure you know where it is when you leave the meeting today.
- The cross in the parking lot has been completed. We have power to add lights in the future but still
 trying to decide on lighting placement and size. Anyone who is willing to help figure this out please let
 me know.
- We are still trying to work on setting up another CPR class in the evenings for people who desire training but work during the day. The instructor proposed a Wednesday night class. I need to check with church calender and people who may be interested.
- We are still trying to come up with an idea for new panels in the ARC that will overcome the issues with the existing configuration. Anyone who has an idea and willing to help please contact myself.
